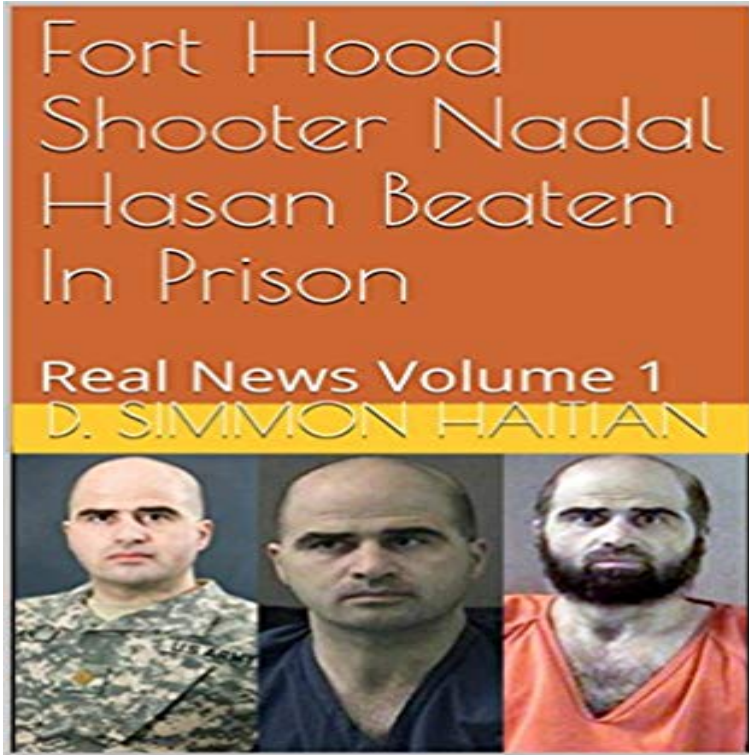


Fort Hood Shooter Nadal Hasan Beaten In Prison: Real News Volume 1
