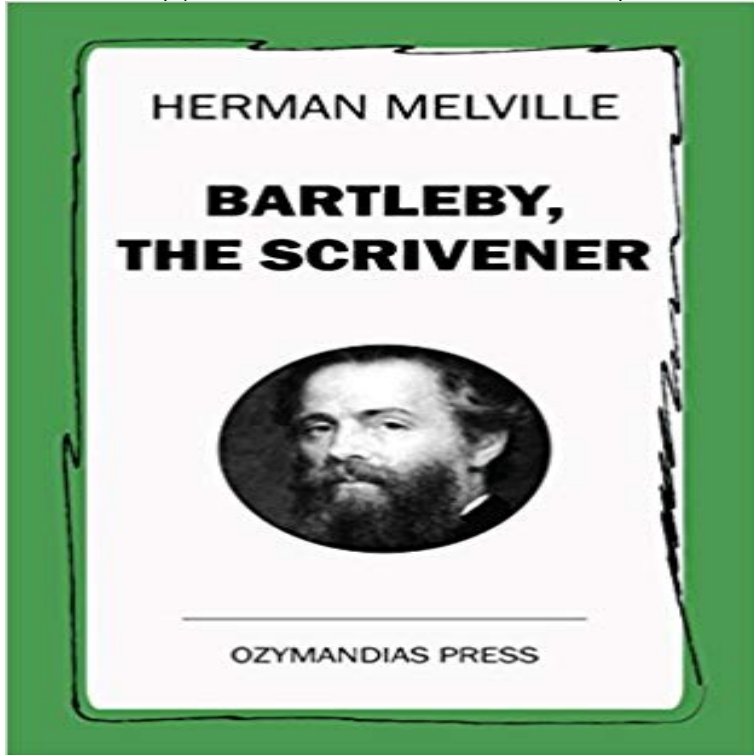


Bartleby, the Scrivener: A Story of Wall Street
